# BRIDGETON'S FOOD TRUCK PARK

## PARTICIPATION CONTRACT

I, \_\_\_\_\_, (hereinafter Exhibitor), enter into this Agreement with Sunrise Catering Unltd, LLC and the parties covenant and agree as follows:

A. Exhibitor hereby agrees to participate as a vendor in the Food Truck Park 2017.

B. Sunrise Catering Unltd hereby agrees to provide Exhibitor space for vending per exhibition area on the dates specified of the vending. Describe in detail all items to be sold in your tent or space i.e. types of food, – **ANY ITEM NOT LISTED CANNOT BE SOLD BY YOU!!!!**

C. Exhibitor agrees to pay the amount of \_\_\_\_\_ for exhibition space payable by check credit card, or money order to Sunrise Catering Unltd, Newark, NJ 07106 on or before start date \_\_\_\_\_.

D. Exhibitor may set-up at Sunset Lake, or other location near Zoo, in Bridgeton City Park & Zoo, Bridgeton, NJ \_\_\_\_\_. Exhibitor may leave food truck or trailer at location at exhibitors own risk.

E. Exhibitor understands and agrees that Sunrise Catering Unltd and its sponsors are not responsible for loss of or damage to good or property of Exhibitor, or personal injury to Exhibitor and/or its employees, and Exhibitor upon signing the Agreement, expressly releases Sunrise Catering Unltd and its' sponsors from all such claims.

F. Exhibitor agrees to conduct themselves in a professional manner at all times while operating in the park.

G. Exhibitor agrees to display all necessary permits and that such permits be made available for viewing upon request.

H. Exhibitor agrees to keep the area around their area free of trash, litter and food stuffs and shall be responsible for removing any loose packaging, containers, or similar items, as a condition of operating in the park.

I. Exhibitor agrees to indemnify and save harmless Sunrise Catering Unltd and its members and employees from any and all property damages, personal injuries, and related losses resulting from vendor's acts and/or omissions and agrees that claims are not limited to insurance coverage. Vendors will not be allowed on the ground **UNLESS AGREED AMOUNT IS PAID IN FULL**. There is no security available; so vendors are required to secure their goods.

J. Exhibitor agrees to promote the mobile food park and the Bridgeton community through social media and other appropriate outlets while under contract with Food Truck Park.

K. Exhibitor agrees to abide by all instructions given by designated identified Committee members and vend only in the same area assigned. Exhibitor warrants that it will obey all rules, regulations, and laws of the State of New Jersey.

L. Exhibitor agrees not to assign, sublet, or share the whole or any part of its assigned space with anyone including any individuals, organizations, or group but will maintain and operate said tent in his/her name as a sole vendor per Agreement. Vendors may not spread out from their assigned areas, blocking aisles or imposing on the space assigned another vendor. Vendors may not roam the grounds and sell from portable areas.

M. Exhibitor agrees that Sunrise Catering Unltd will not provide electrical receptacles. Electrical receptacles are located in the park for use. Lighting will not be provided by Sunrise Catering Unltd and sponsors.

N. Exhibitor agrees that Sunrise Catering Unltd will not provide garbage bins. Exhibitor must provide garbage bin.

O. Alcohol beverages are prohibited. In the case of a special occasion or event, only approved vendors (with an alcohol license) will be permitted to serve alcohol.

P. Exhibitor agrees that any violations or regulations which are hereby incorporated into this Agreement, or provisions of this agreement occurring during Food Truck Park, will result in immediate termination of said Agreement and Exhibitor removal from the exhibition area. In case of vendor removal, all fees are forfeited. Directions to the park can be obtained by visiting the website @ <http://www.sunrise-catering-unltd.com/food-truck-park.html>.

Q. Sunrise Catering Unltd reserves the right and discretion to make location assignments of all exhibition space. Exhibitor understands and agrees that should they cancel space reserved under the Agreement, they are not entitled to a refund and that all fees are non-refundable. Exhibitor agrees to the terms of this Agreement and is consistent with the laws and the courts of Bridgeton, NJ. Park regulations will be enforced.

R. Please take note – During the hours of the Food Truck Park, vehicles must be parked in designated area. All vendors must set up before opening time. Large goods can be brought in by hand cart only to the Park site.
